Support for the Heartland Visa Act of 2024

"The Heartland Visa Act would provide American communities with a powerful new tool for economic growth, innovation, and revitalization," said **John Lettieri, President and CEO of the Economic Innovation Group**. "This legislation recognizes that highly skilled immigrants deliver vital benefits to U.S. workers and communities, from new jobs and businesses to higher wages to more tax revenues that support essential local services. Enacting a Heartland Visa is a long-overdue way to ensure that these benefits reach areas of the country left behind by U.S. immigration policy for too long."

"Today, high-growth startups—and the jobs and economic vitality that they bring—remain concentrated in a few coastal cities, with roughly 75 percent of venture capital going to just three states: California, New York, and Massachusetts. I applaud Senators Young and Manchin for championing this bipartisan solution to create a more regionally diverse innovation economy."

"Rural towns and counties across the United States are in economic free-fall due to population decline and brain-drain," said **Samuel Hammond, Senior Economist at the Foundation for American Innovation**. "An opt-in program for communities in America's heartland to attract entrepreneurial and high-skilled immigrants can not only help stem the tide, but would lay the foundations for long-term economic development and revitalization."

The Heartland Visa perfectly encapsulates <u>AFP's Four Pillars of Border Security and Visa Reform</u>, which calls on Congress to pass legislation to secure the border, clarify immigration law, and make America a more competitive nation."

The U.S. Conference of Mayors adopted a bipartisan resolution in 2024 calling on Congress to assist cities in confronting their economic and demographic challenges and endorsed a Heartland Visa "that would provide a new pathway for skilled immigrants and immigrant entrepreneurs who wish to settle in welcoming communities facing population stagnation or decline that would opt-in to such a policy if it aligns with their local economic development goals."
